ENFORCEMENT NOTICE

OPERATIONAL DEVELOPMENT

The Town and Country Planning Act 1990 (as amended)



ISSUED BY THE CITY AND COUNTY OF SWANSEA ("The Council")

COUNCIL REFERENCE ENF2018/0141

1. **THIS NOTICE** is issued by the Council because it appears to them that there has been a breach of planning control under Section 171A(1)(a) of the Town and Country Planning Act 1990 at the land described below. They consider that it is expedient to issue this Notice having regard to the provisions of the development plan and all other material planning considerations. The **annex** at the end of the Notice contains important additional information.

2. **THE LAND TO WHICH THIS NOTICE RELATES**

Land at 1/1A Wern Fawr Road Port Tennant Swansea SA1 8LQ in the City and County of Swansea ("the Land"), shown edged red on the plan appended hereto ("the Plan").

3. **THE MATTERS WHICH APPEAR TO CONSTITUTE THE BREACH OF PLANNING CONTROL**

Without planning permission, the erection of an extractor flue.

REASONS FOR ISSUING THIS NOTICE

- i. It appears to the Council that the above breach of planning control has occurred within the last four years.
- ii. The flue by virtue of its design, form and siting fails to respect the character and appearance of the property and wider street scene on a prominent location contrary to the aims and requirements of Policies EV1 criteria (i), (ii), (iii), (iv) and EV2 criteria (i) of the Adopted City and County of Swansea Unitary Development Plan 2008.

5. **WHAT YOU ARE REQUIRED TO DO**

- i. Remove the extraction flue
- ii. Remove from the land all building materials and /or rubble arising from compliance with i above

6. **TIME FOR COMPLIANCE**


1 month beginning with the day on which this notice takes effect.

7. WHEN THIS NOTICE TAKES EFFECT

This Notice takes effect on the 18th May 2018 unless an appeal is made against it before that date.

YOUR RIGHT OF APPEAL

ENFORCEMENT NOTICE APPEAL FEES

Should you choose to appeal this Notice on the grounds that planning permission should be granted for what is alleged in the Notice (Ground a) you are required to pay a fee to the Local Planning Authority. The fee payable in this instance is **£670**. Payments can be made to the City & County of Swansea Council, Planning Control, Civic Centre, Oystermouth Road, Swansea SA1 3SN quoting the reference number as specified on the Enforcement Notice.

WHAT HAPPENS IF YOU DO NOT APPEAL

If you do not appeal against this Enforcement Notice, it will take effect on the date specified in paragraph 7 of the Notice and you must then ensure that the required steps for complying with it, for which you may be held responsible, are taken within the period(s) specified in paragraph 6 of the Notice. Failure to comply with the Enforcement Notice which has taken effect can result in prosecution and/or remedial action by the Council.

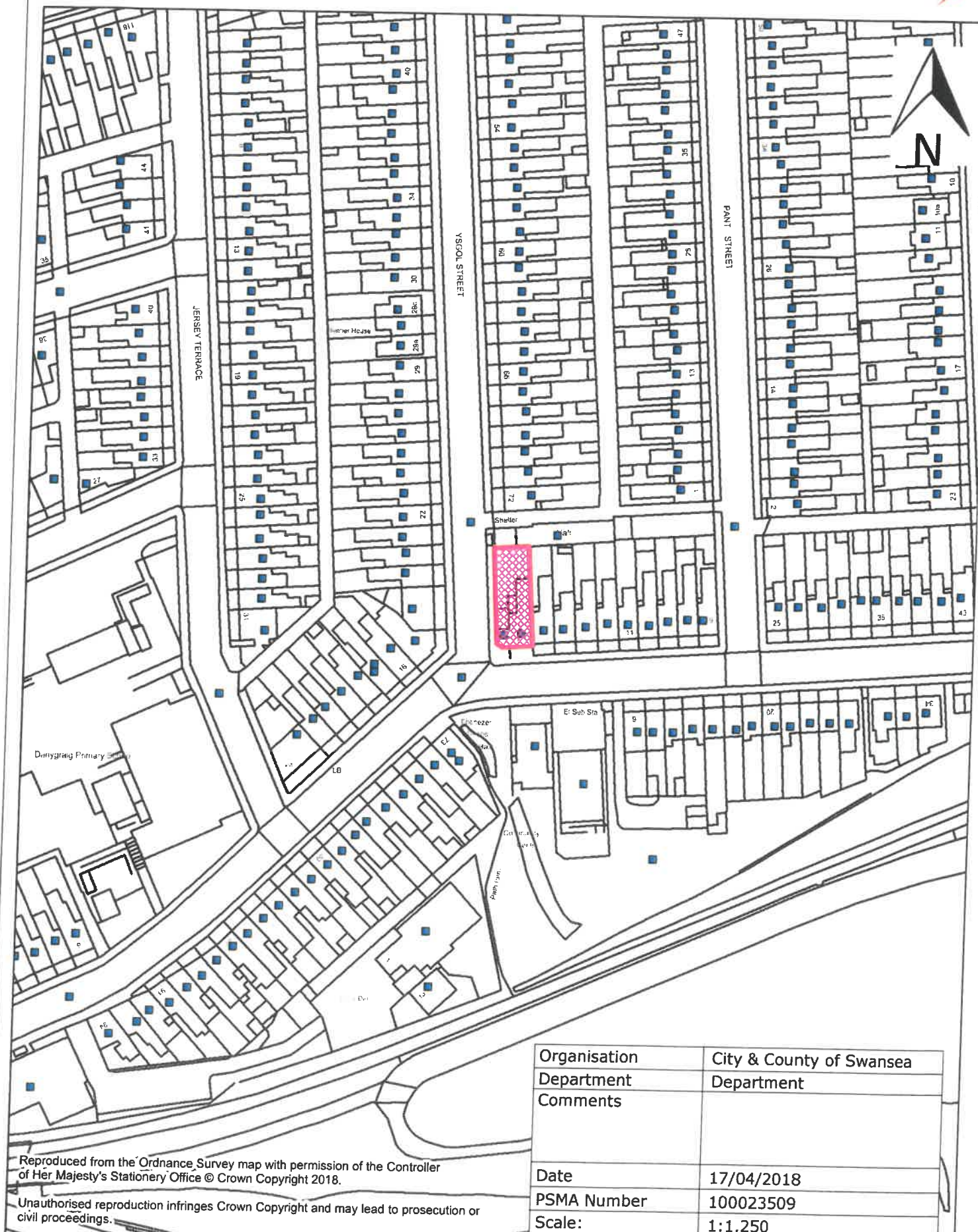
