REVOCATIONS

The existing Orders are revoked insofar as they are inconsistent with the proposals hereinafter contained which relate to the length or lengths of the road or roads referred to in the schedules hereto.

SCHEDULE 2

NO WAITING AT ANY TIME

GREENWAYS

On its southern side from its junction with the southern kerbline of Camrose Drive westwards to a point 5 metres west of its junction with the western kerbline of Brithwen Road and

On its northern side from a point 12 metres east of its junction with the eastern kerbline of Brithwen Road westwards to a point 5 metres west of its junction with the western kerbline of Brithwen Road.

BRITHWEN ROAD

On its western side from a point 23 metres north of its junction with the northern kerbline of Greenways southwards to a point 6 metres south of its junction with the southern kerbline of Greenways and

On its eastern side from a point 5 metres north of its junction with the northern kerbline of Greenways southwards to a point 6 metres south of its junction with the southern kerbline of Greenways.

SCHEDULE 3

20 MPH SPEED LIMIT

GREENWAYS

Throughout its length from its junction with Heol Cleddau westwards to its junction with Brithwen Road.

RAISED TABLE JUNCTION

At the junction of Greenways with Brithwen Road.

The provision of double yellow lines is for the purpose of improving road safety and assisting traffic flow on the road fronting the new housing development.

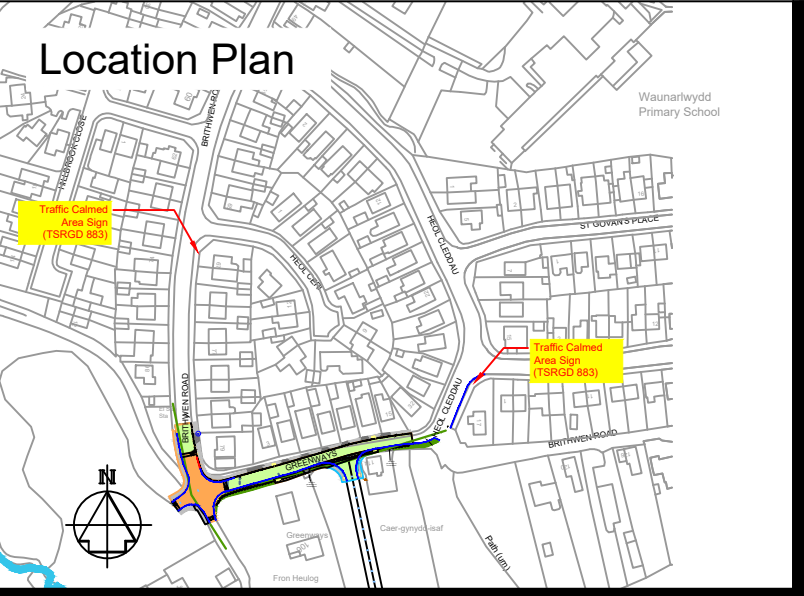
Extract from RTRA 1984

2What a traffic regulation order may provide.

(1) A traffic regulation order may make any provision prohibiting, restricting or regulating the use of a road, or of any part of the width of a road, by vehicular traffic, or by vehicular traffic of any class specified in the order,—

(a) either generally or subject to such exceptions as may be specified in the order or determined in a manner provided for by it, and

(b) subject to such exceptions as may be so specified or determined, either at all times or at times, on days or during periods so specified.
