TEMPORARY STOP NOTICE

(as amended by the Planning (Wales) Act 2015)**

ISSUED BY THE CITY AND COUNTY OF SWANSEA ("The Council")

To: **Owner/Occupier**

Address: **Land identified on the attached Plan and in Appendix A, as described in Paragraph 4 below.**

1. The Council considers that there has been a breach of planning control on the land described in paragraph 4 below. The breach of planning control is **an unauthorised engineering operation**, comprising the excavation of a boundary feature without securing the appropriate consent.
2. This temporary stop notice is issued by the Council, in exercise of their power in section 171E of the 1990 Act, because they think that it is expedient that the activity specified in this notice should cease on the land described in paragraph 4 below. The Council now prohibits the carrying out of the activity specified in this notice. Important additional information is given in the Annex to this notice.

3. THE REASONS FOR ISSUING THIS NOTICE

The engineering operation gives rise to significant concerns relating to adverse ecological impacts, land drainage issues and potential impacts upon public and highway safety.

4. THE LAND TO WHICH THIS NOTICE RELATES

Land to the south of Camrose Drive, adjacent To Rock House/Mill Farm Caergynydd Isaf Waunarlywydd as identified on Appendix A and shown hatched red on the attached plan.

5. ACTIVITY TO WHICH THIS NOTICE RELATES

The undertaking of unauthorised engineering operations on the site.

6. WHAT YOU ARE REQUIRED TO DO


Cease all the activity specified in the Notice within the area identified on the plan and Appendix A. *(Only works agreed in writing with the Local Planning Authority in advance may be undertaken within this 28 day period)

7. WHEN THIS NOTICE TAKES EFFECT

This notice takes effect on 3rd February 2021 when all the activity specified in this notice must cease. This notice will cease to have effect on the 3rd March 2021

It is an offence to contravene a temporary stop notice after a site notice has been displayed or the temporary stop notice has been served on you (section 171E(4) and 171G of the 1990 Act). If you then fail to comply with the temporary stop notice you will be at risk of **prosecution** in the Magistrates' Court, for which the maximum penalty is £20,000 on summary conviction for a first offence and for any subsequent offence.

The fine on conviction on indictment is unlimited. If you are in any doubt about what this notice requires you to do, you should get in touch **immediately** with:

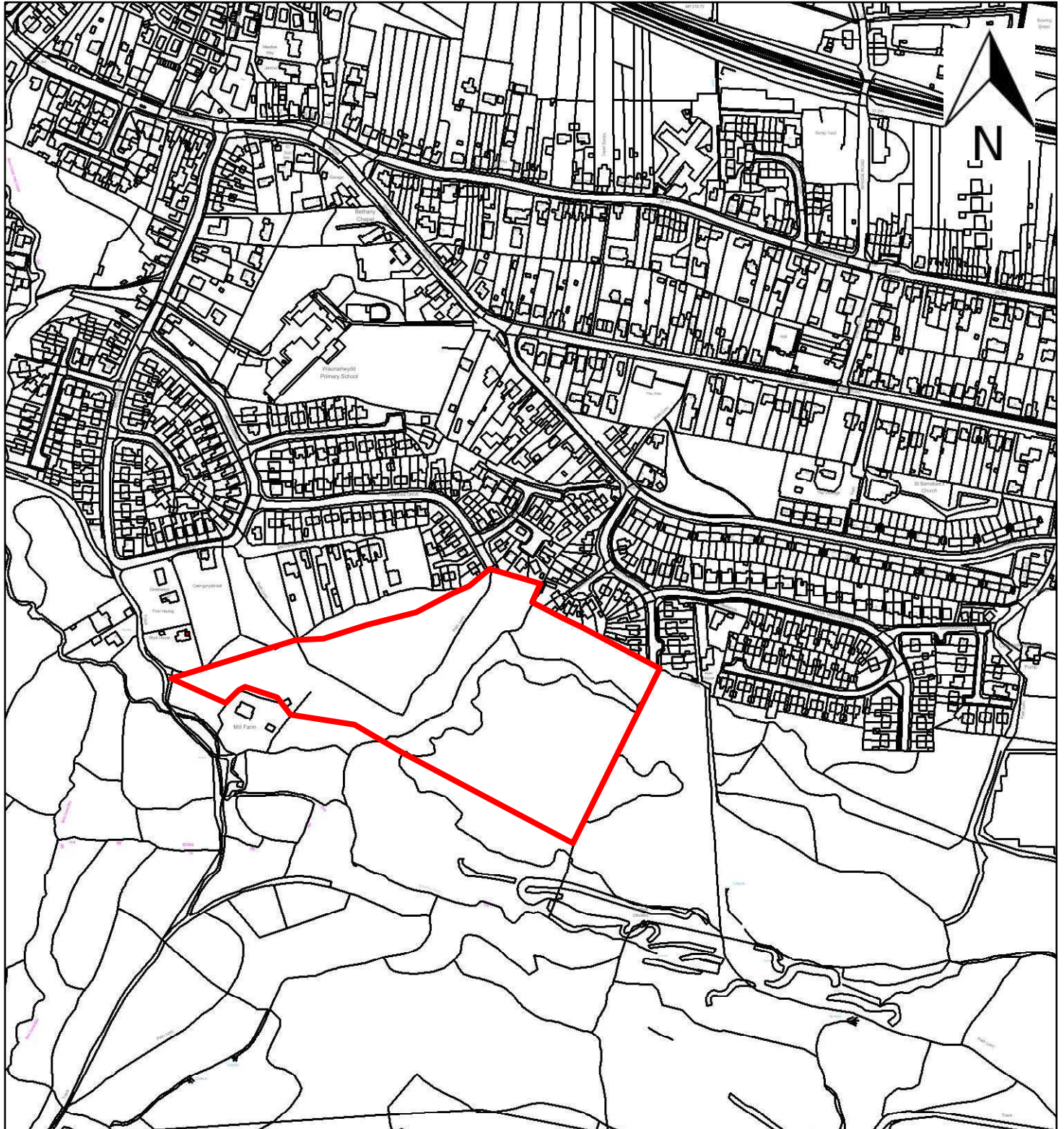
