

Definitions

2. In this order, except where the context otherwise requires, the following expressions have the meaning hereby respectively assigned to them:

"Motor Vehicle(s)" has the same meaning as that defined in s136 Road Traffic Regulation Act 1984.

Interpretation

- 3. Except where otherwise stated, any reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order
- 4. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the Interpretation of an Act of Parliament

 The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation of any other prohibition or restriction whether made under the Act of 1984 or otherwise

SECTION 2 - PROHIBITION OF MOTOR VEHICLES

6. No person shall cause any Motor Vehicle to proceed along the length or lengths of road or roads as referred to in Schedule 2 hereto
