

**NOTICE OF MAKING AN ORDER
HIGHWAYS ACT 1980
THE COUNCIL OF THE CITY AND COUNTY OF SWANSEA
FOOTPATH 10 COMMUNITY OF PONTARDULAIS
PUBLIC PATH DIVERSION ORDER 2024**

The above Order, made on the 7th day of February 2024 under Section 119 of the Highways Act 1980, will divert the public footpath running from a point on the tarmac path 70 metres south of the park entrance at grid reference SN 591032 and proceeding in a south south westerly direction for 150 metres to the tarmac track south of the playing fields at grid reference SN 591031 and to a line commencing at the same point and proceeding along the tarmac path in a south south easterly direction for 155 metres to grid reference SN 592031.

A copy of the order and the order map may be seen at all times on the notice board outside the main entrance of the Swansea Council offices at the Civic Centre, Swansea SA1 3SN and may be obtained free of charge at the Civic Centre reception desk between 8.30 a.m. and 4.00 p.m. Mondays to Fridays. The notice and order can also be seen at www.swansea.gov.uk/Publicpathorders

Any representations about or objections to the Order may be sent in writing to the Head of Planning & City Regeneration, Civic Centre, Swansea no later than 11th March the 2024 and should state the grounds on which they are made. If no representations or objections are duly made or if any so made are withdrawn, the Council of the City and County of Swansea may confirm the Order as an unopposed Order. If the Order is sent to the Welsh Ministers for confirmation, any representations and objections which have not been withdrawn will be sent with the Order.

PUBLIC PATH DIVERSION ORDER 2024
HIGHWAYS ACT 1980
THE COUNCIL OF THE CITY AND COUNTY OF SWANSEA
FOOTPATH 10, COMMUNITY OF PONTARDULAIS

This order is made by The Council of the City and County of Swansea ("the Authority") under Section 119 of the Highways Act 1980 ("the 1980 Act") because it appears to the Authority that in the interests of the owner and occupier of the land crossed by the footpath it is expedient that the line of footpath should be diverted.

BY THIS ORDER:

1. The public right of way over the land situated at Coed Bach Park and shown by a bold continuous line on the map contained in this order and described in part I of the Schedule to this order shall be stopped up after 8 days from the date of confirmation of this order.
2. There shall be at the end of 7 days from the date of confirmation of this order a public footpath over the land situated at Coed Bach Park described in Part 2 of the Schedule and shown by a broken line on the map contained in this order.

SCHEDULE

PART 1

DESCRIPTION OF SITE OF EXISTING PATH OR WAY

Commencing at point A (grid reference SN 591032) and proceeding in a south south-westerly direction for 150 metres to point B (grid reference SN 591031).

PART 2

DESCRIPTION OF SITE OF NEW PATH OR WAY

Commencing at point A (grid reference SN 591032) and proceeding in a south easterly direction two point D and then in a south south-easterly direction to point C (grid reference SN 592031).

Width of new footpath 2 metres.

Length of new footpath 155 metres.

All distances and directions are approximate.
