NOTICE is hereby given that the Council of the City and County of Swansea in pursuance of its powers under the Road Traffic Regulation Act 1984 (as amended) intend to close the above-mentioned road. In order for Ground Up Solutions Ltd to carry out telecoms works at the above location; it will be necessary to temporarily close the above road in part to vehicular traffic.

Glanmor Crescent from its junction with Glanmor Road, in an Easterly direction to its junction with the grove a distance of approximately 160 metres.

The alternative route for vehicular traffic will be via Glanmor Road, Uplands Terrace and the Grove, a distance of approximately 0.6 kilometres.

Similarly, this route will operate in the reverse direction.

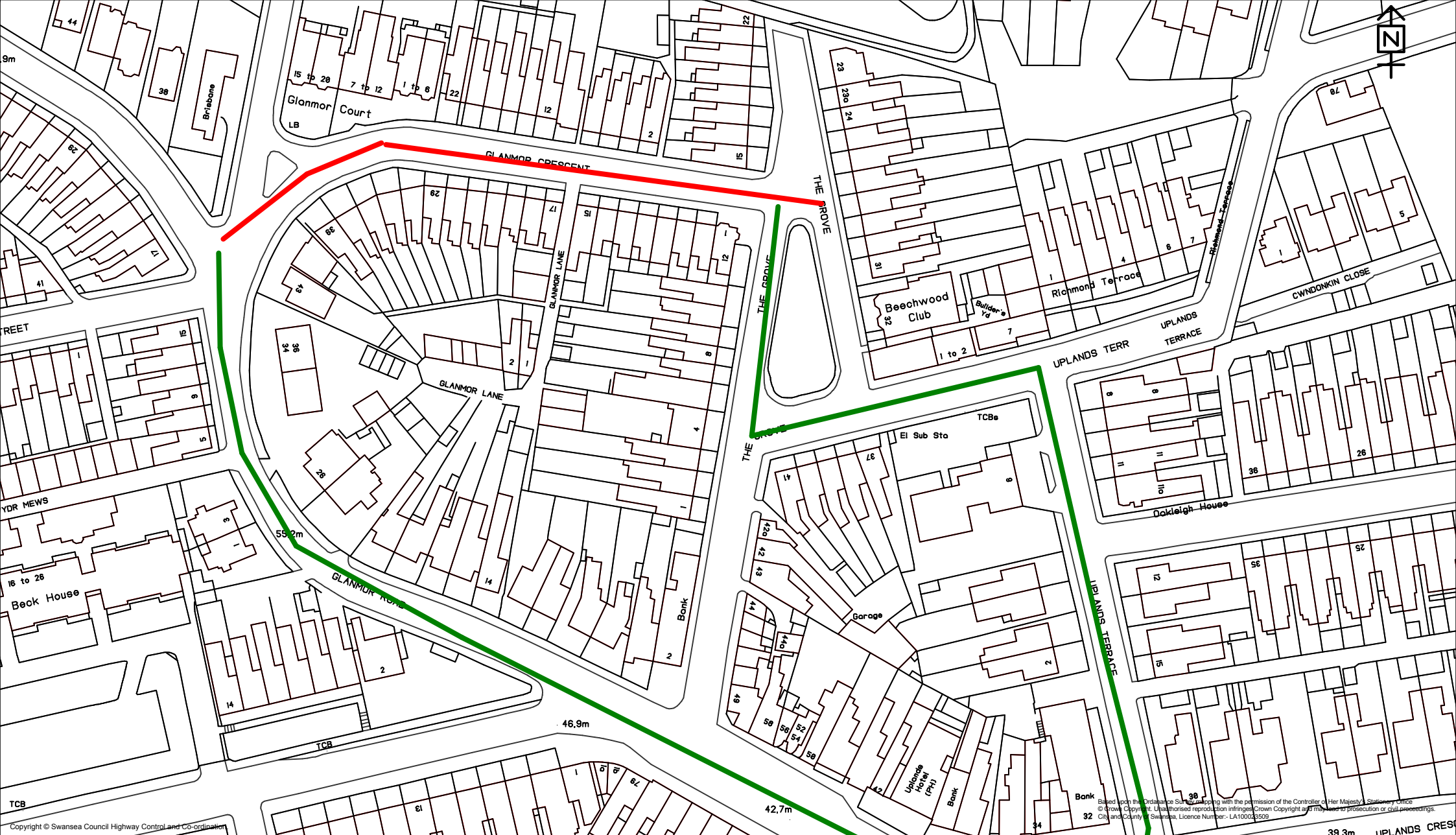
Access for emergency vehicles and pedestrians to be maintained at all times.
