## TEMPORARY ONE-WAY SYSTEM & SPEED RESTRICTIONS **NOTICE 2025**

**NOTICE** is hereby given by the Council of the City and County of Swansea in pursuance of its powers as contained in section 14(1)(b) of the Road Traffic Regulation Act 1984 (as amended) that from Thursday 10th July 2025 for a period of 21 days only (or until the restrictions related to the event are no longer needed whichever is sooner – it is anticipated that the restrictions will be needed for 5 days), no person shall cause any vehicle to be driven or parked as referred to in the schedule below.

## **SCHEDULE**

Event organisers are to hold a Love Trails Festival at Weobley Castle from 12:00hrs Thursday 10<sup>th</sup> July until 12:00hrs Monday 14th July. As a result, it will be considered necessary; in the interests of safety to temporary introduce the following restrictions on Cheriton Road (via Weobley Castle) for the duration of the event.

- One-Way System heading west from Leason to Llandimore to alleviate congestion for local and festival goers on arrival days (Thursday 10th and Friday 11th July) and on exit day (Monday 14th July) this will change to a one way east bound to ease egress from festival site.
- Temporary road crossing and 20mph speed limit in place outside Love Trails Festival gate. providing safe crossing point for festival ticketholders moving from campsite to main festival site (Thursday 10<sup>th</sup> July 12:00 – Monday 14<sup>th</sup> July 12:00).
- Temporary obstruction / Stop/Go operation to manage said pedestrian crossing, operational Thursday 10th July 12:00 – Monday 14th July 12:00.
- 20mph temporary speed restriction at Stembridge Farm junction to allow for safe crossing of runners (Thursday 10<sup>th</sup> July 12:00 –Monday 14<sup>th</sup> July 12:00).

## Access for emergency vehicles to be maintained at all times.

The applicant will be responsible for the erection and maintenance of all advanced warning, Road Closed, diversion and alternative route signs in accordance with Chapter 8 of the Traffic Signs Manual and the Traffic Signs and Regulations and General Directions 2016 for the duration of the works.
