NOTICE 2025

THE COUNCIL OF THE CITY AND COUNTY OF SWANSEA in exercise of the powers conferred by Section 16A of the Road Traffic Act 1984 with consent from Welsh Government and authorisation from South Wales Police, **HEREBY GIVE NOTICE** that on the various dates as shown in the Schedule below and as and when the appropriate traffic signs are displayed no person shall cause a vehicle (other than a vehicle being used for emergency purposes) to proceed or park along the length or lengths of road(s) footpath(s) cycle path(s) in the manor referred to in the Schedules below.

SCHEDULE

The Ironman event is to be held on Sunday 13th July 2025 and will require temporary road closures and traffic restrictions to accommodate the event.

1. TEMPORARY ROAD CLOSURES

The following lengths of road will be closed to prevent any vehicle, horse or cycle from proceeding along unless the vehicle is being used in connection with the event; or being used emergency purposes. The restrictions are necessary to ensure the safety of all road users and the safe passage of participants in the Ironman Swansea 70.3 Triathlon Event on the dates and times specified in the sections below.

The Order will not, at any time, prevent access of pedestrians to premises situated on or adjacent to any road to which the order relates, or to any premises only accessible to pedestrians from such a road.

(All orders are required for the full length unless specified otherwise)

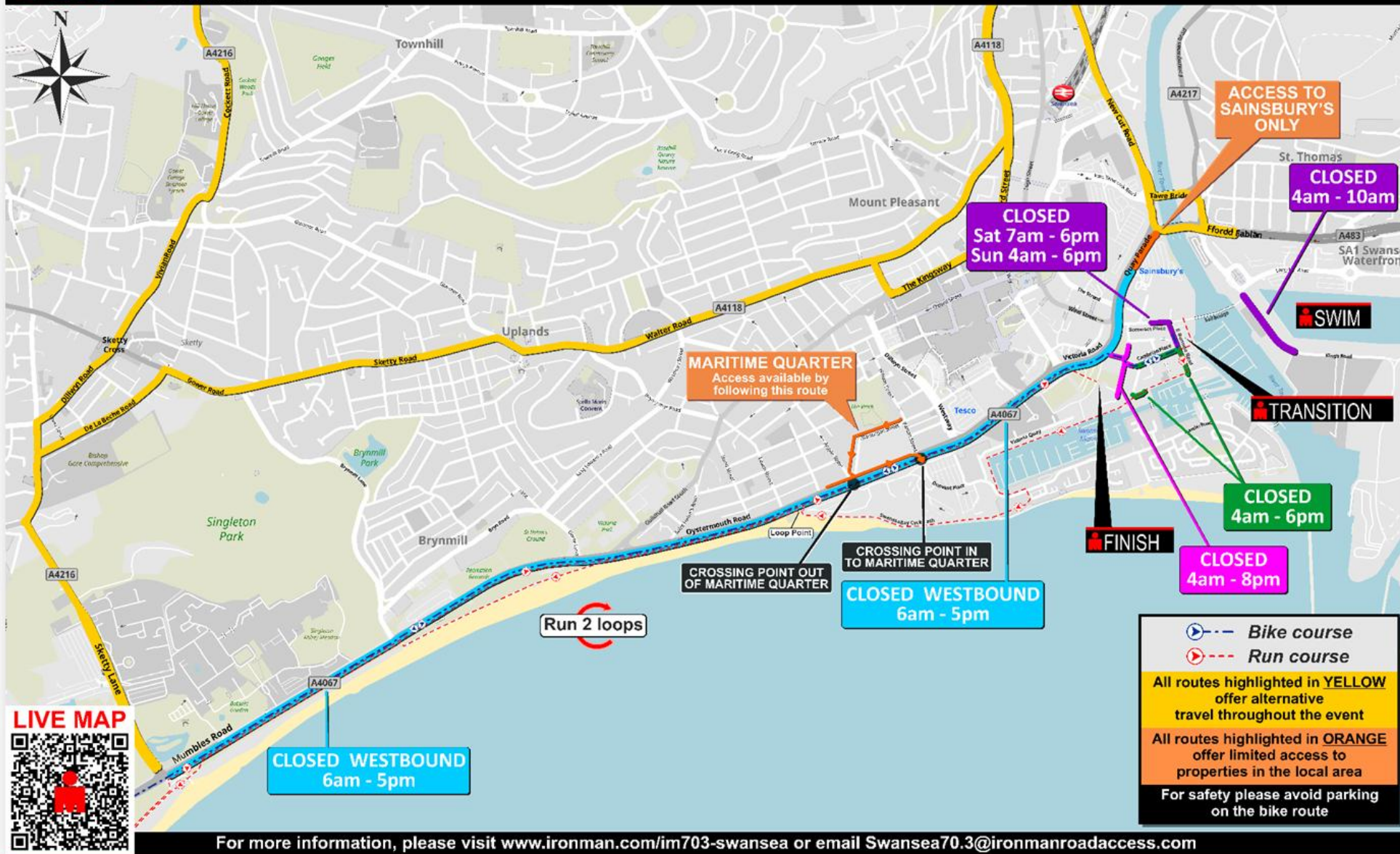

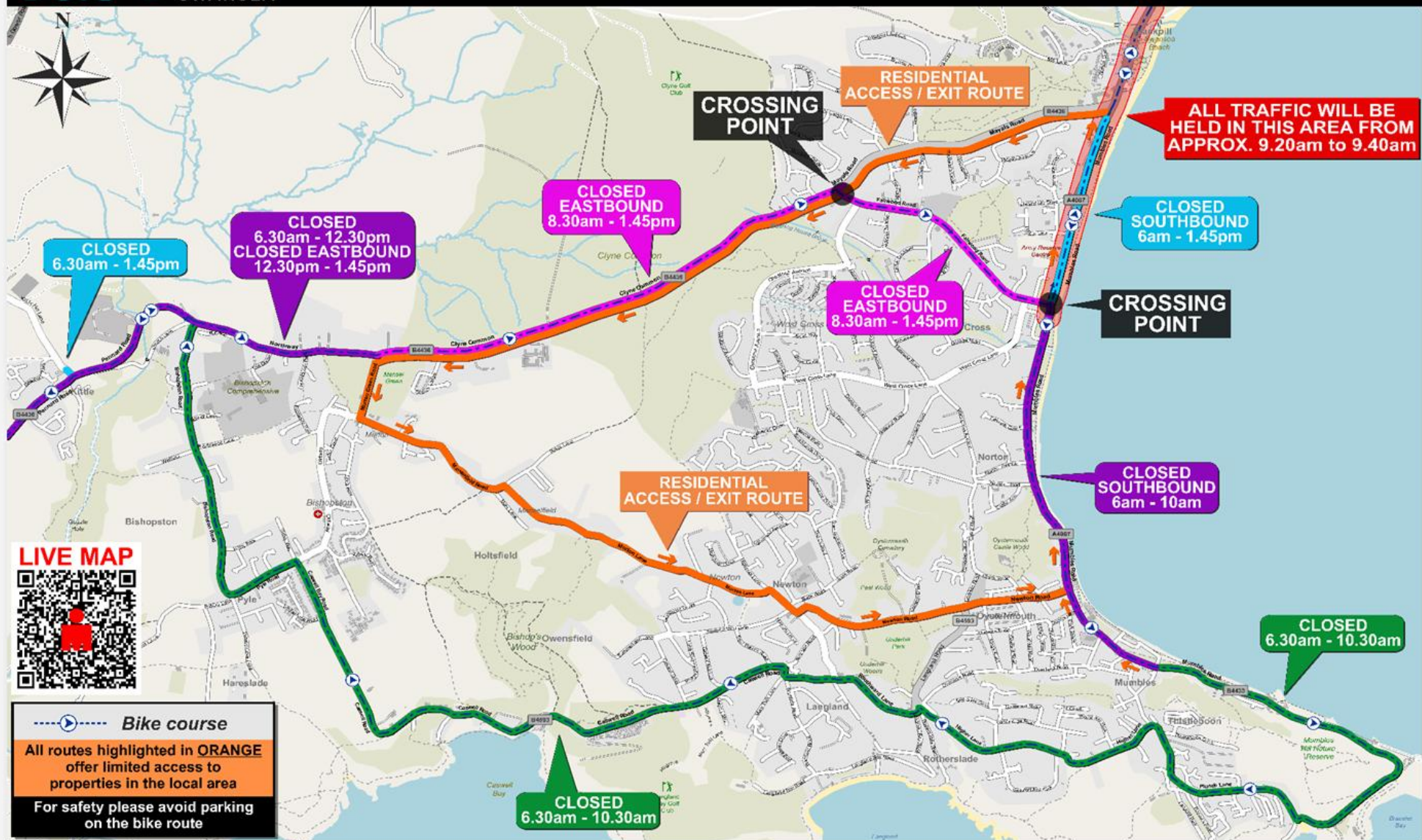
