NOTICE 2025**

NOTICE is hereby given by the Council of the City and County of Swansea in pursuance of its powers as contained in section 14 (2) of the Road Traffic Regulation Act 1984 (as amended) that from **Wednesday 19th November 2025** for a period of 21 days only (or until the works are completed whichever is sooner – it is anticipated that the work will take 21 days to complete), no person shall cause any vehicle to be driven as referred to in the schedule below. In order for Network Plus Services on behalf of DCWW to undertake repairs to a burst water main, it has been necessary to temporarily close the above road to vehicular traffic.

**SCHEDULE – TEMPORARY EMERGENCY ROAD CLOSURE
BRYNYMOR CRESCENT, CRESCENT SWANSEA**

Brynymor Crescent in an south easterly direction from its junction with Walter Road to its junction with King Edward Road a distance of approximately 340 metres.

The alternative route for vehicular traffic will be via, B4290 St Helens Road, B4290 The Kingsway, Christina Street, A4118 Mansel Street and A4118 Walter Road, a distance of approximately 1.8 Kilometres.

This route will operate in the opposite direction.

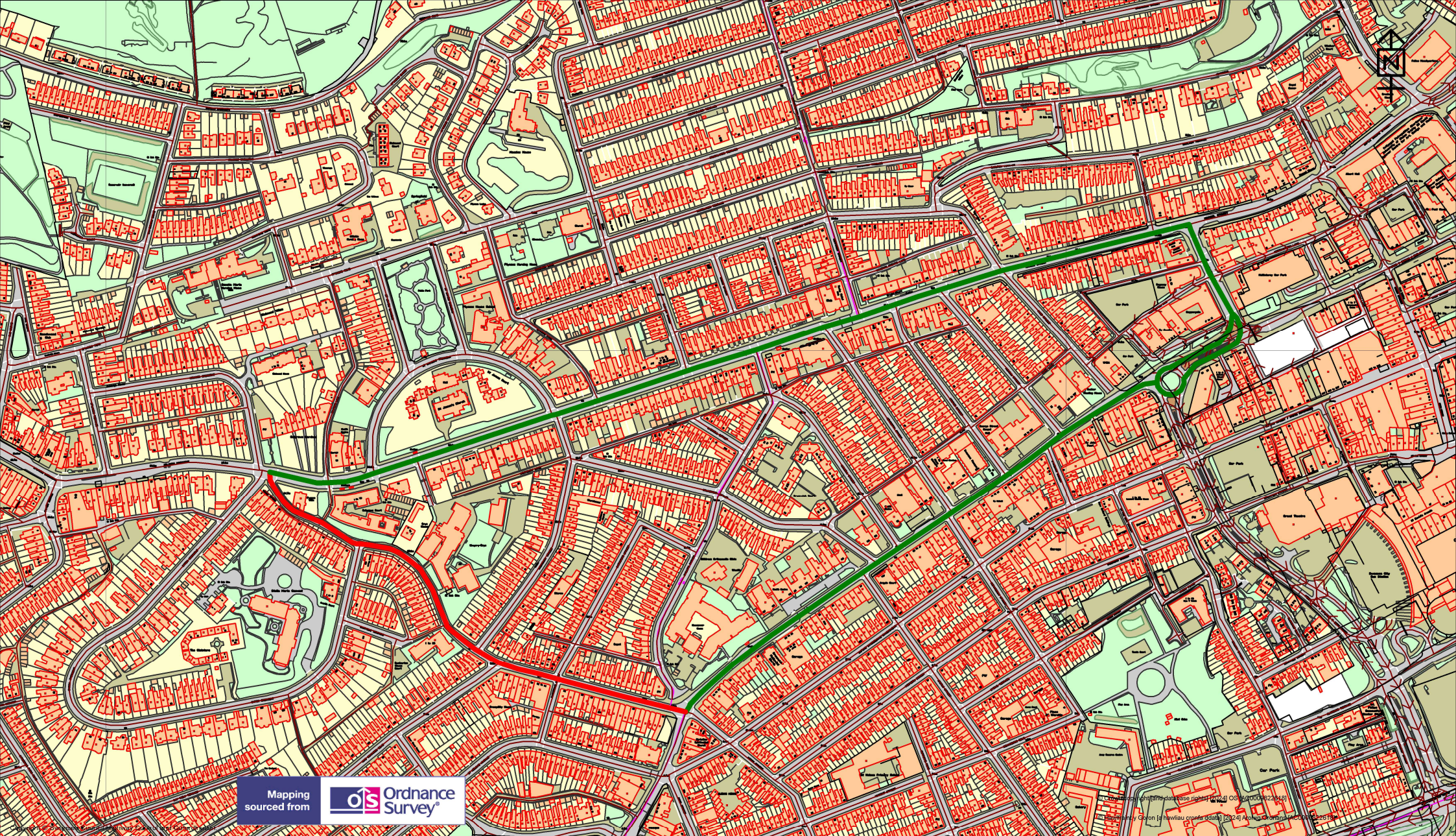
Access for emergency vehicles and pedestrians to be maintained at all times.
