


# **KILLAY NORTH WARD PROFILE**

Profiles on the basis of the new wards will be developed as soon as possible.




- **Population: 2,800** (source: mid-2020 estimates, rounded Office for National Statistics / ONS)
- Location: Approximately 6 kilometres west of Swansea city centre
- Neighbouring Wards: Killay South, Dunvant, Gowerton, Cockett, Sketty
- Constituency area (Welsh Government / UK Parliament): Swansea West
- > Area: 194 hectares / 1.94 km² (ONS, 2020)
- Population Density (2020): 1,422 people per km²
- **Population Change** (2015 to 2020): -600 / -17% (ONS estimates, rounded)
- **Employment**: 225 (ONS workplace estimate, 2020). Major employers: Swansea Council (primary school).


#### ABOUT THE WARD

Killay is one of a string of Victorian hamlets on Gower Road that rapidly grew during the early 1900s and was subsequently absorbed by the western expansion of urban Swansea. It has since developed as an attractive residential suburb.

The twentieth century development of Killay North can be broadly subdivided into three areas and phases. The first phase involved the development during the 1940s and 1950s of private semi-detached homes around the Wimmerfield Crescent area. The next phase coincided with the expansion of the University and creation of the Student Village which was constructed in phases between 1973 and 1993 (although the extent of the village is now reducing as the student accommodation is being relocated). In the 1990s, housing developments in the Hendrefoilan Woods area further contributed to population growth.

#### SOCIO-ECONOMIC DATA

- ➤ Estimates of average net annual household income for Killay North are available via ONS model-based estimates at MSOA (Middle Super Output Area) level for 2015/16. The figure for Swansea 023, the MSOA which most closely aligns to the ward (see map adjacent), is £32,200; the 3<sup>rd</sup> highest (of 31 MSOAs) in Swansea and 20% above the Swansea median of £26,900.
- NS-SeC data (socio-economic position based on occupation) for the ward indicates a very high proportion of residents in the 'not classified' category, which in the NS-SeC classification includes students (which is to be expected in an area containing the Student Village).



#### WELSH INDEX OF MULTIPLE DEPRIVATION

- WIMD 2019 based on Lower Super Output Area (LSOA) geography – Killay North ward consists of two LSOAs (one whole, one part LSOA).
- Killay 3 (created by combining the former Killay North 1 and Killay South 2 LSOAs) is ranked 142<sup>nd</sup> in Swansea and 1,885<sup>th</sup> in Wales, reflecting low levels of relative deprivation.
- ➤ Killay North 2 is the less deprived of the two LSOAs in the ward, ranked 145 in Swansea (out of 148) and 1,897 in Wales (of 1,909).
- ➤ In relative terms, the highest deprivation ranking in Killay 3 is recorded in the physical environment domain, although no domain ranking for either LSOA is close to the 50% most deprived in Wales.
