


# MAWR WARD PROFILE


## Information, Research & GIS (Strategic Delivery Unit), April 2022

Profiles on the basis of the new wards will be developed as soon as possible.




- **Population: 1,900** (source: mid-2020 estimates, rounded Office for National Statistics / ONS)
- Location: Approximately 16 kilometres north of the city centre, consisting of Craig Cefn Parc. Felindre and Garnswllt localities
- Neighbouring Wards (Swansea): Clydach, Morriston, Llangyfelach, Pontarddulais
- Constituency area (Welsh Government / UK Parliament): Gower
- Area: 5,782 hectares / 57.82 km² (ONS, 2020)
- Population Density (2020): 32 people per km²




#### ABOUT THE WARD

Mawr, the county's least densely populated ward, comprises largely open, upland green space, apart from the villages of Craig Cefn Parc (in the south eastern part), Garnswllt (close to the County's northern boundary) and Felindre (in the south west). The remainder comprises mainly scattered farm developments.

The two villages of Craig Cefn Parc and Garnswllt grew up around the coal mining and related industries, dating back to at least the 19<sup>th</sup> Century. Craig Cefn Parc is today a mixture of local authority housing, traditional semi-detached 'worker houses' and modernised, large detached properties. Garnswllt exhibits a similar mixture of styles.

### SOCIO-ECONOMIC DATA

▶ Estimates of average net annual household income for Mawr are available via ONS model-based estimates at MSOA (Middle Super Output Area) level for 2015/16. The figure for Swansea 002, the MSOA which most closely aligns to the ward (see map adjacent), is £25,900; the joint 14<sup>th</sup> lowest (of 31 MSOAs) in Swansea and 4% below the Swansea median of £26,900.



NS-SeC data (socio-economic position based on occupation) for the ward indicates a slightly higher than average level of managerial and professional occupations (NS-SeC classes 1-2) and intermediate occupations (NS-SeC classes 3-4).



### WELSH INDEX OF MULTIPLE DEPRIVATION

- WIMD 2014 based on Lower Super Output Area (LSOA) geography – Mawr consists of one LSOA.
- ➤ In terms of the overall index, Mawr ranked 72<sup>nd</sup> of 148 in Swansea and 1,029<sup>th</sup> of 1,909 in Wales.
- Levels of deprivation recorded in the Index are generally low, with most domains showing middle or low rankings.
- ➤ The exception is the access to services domain for which Mawr ranks as the 2<sup>nd</sup> most deprived LSOA in Swansea (128 in Wales), reflecting its rural location and distance from amenities. The next highest ranking is in the housing domain.
