**SCHEDULE 2 - TEMPORARY PARKING PROHIBITION  
PRINCE OF WALES ROAD (PART), CITY CENTRE**

Prince of Wales in a north-easterly direction from its junction with B4489 High Street for a distance of approximately 50 metres

The maximum duration of the order is 18 months and it is anticipated the work will take **60 weeks** to complete effective from **Wednesday 3rd November 2021**.

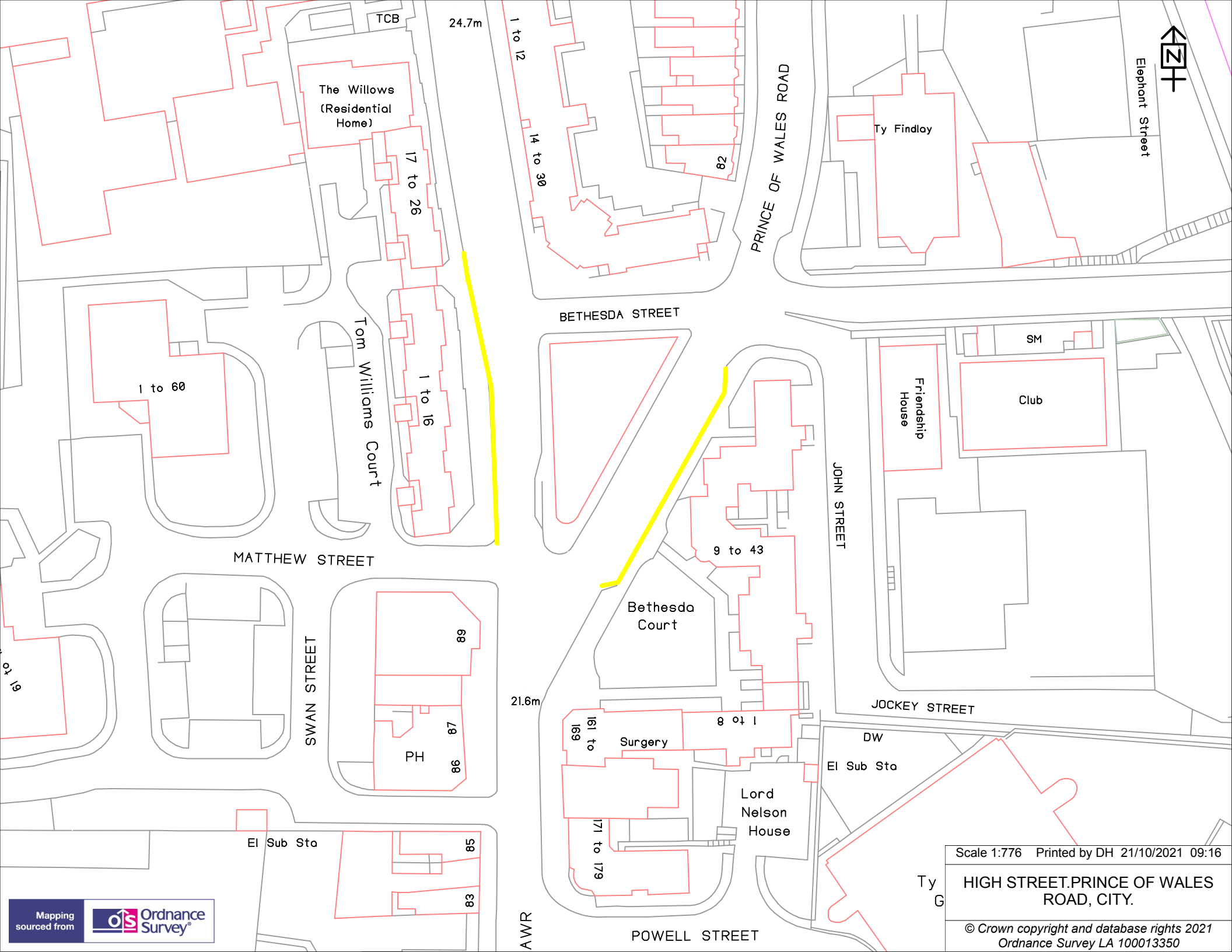
