NOTICE 2022**

NOTICE is hereby given by the Council of the City and County of Swansea in pursuance of its powers as contained in section 14 (2) of the Road Traffic Regulation Act 1984 (as amended) that from **Monday 10th January 2022** for a period of 21 days only (or until the works are completed whichever is sooner – it is anticipated that the work will take 3 days complete), no person shall cause any vehicle to be driven as referred to in the schedule below. In order for Morrison Utility Services to carry out leakage works on behalf of Dwr Cymru/Welsh Water at the above location, it has been necessary to temporarily close the above road to vehicular traffic.

**SCHEDULE - TEMPORARY EMERGENCY ROAD CLOSURE
WOODVILLE ROAD, MUMBLES**

Woodville Road in a southerly direction from its junction with Queens Road to its junction with Overland Road, a distance of approximately 200 metres.

The alternative route for vehicular traffic will be via Queens Road, Dunns Lane, Oakland Road and Overland Road, a distance of approximately 340 metres.

Similarly, this route will operate in the reverse direction.

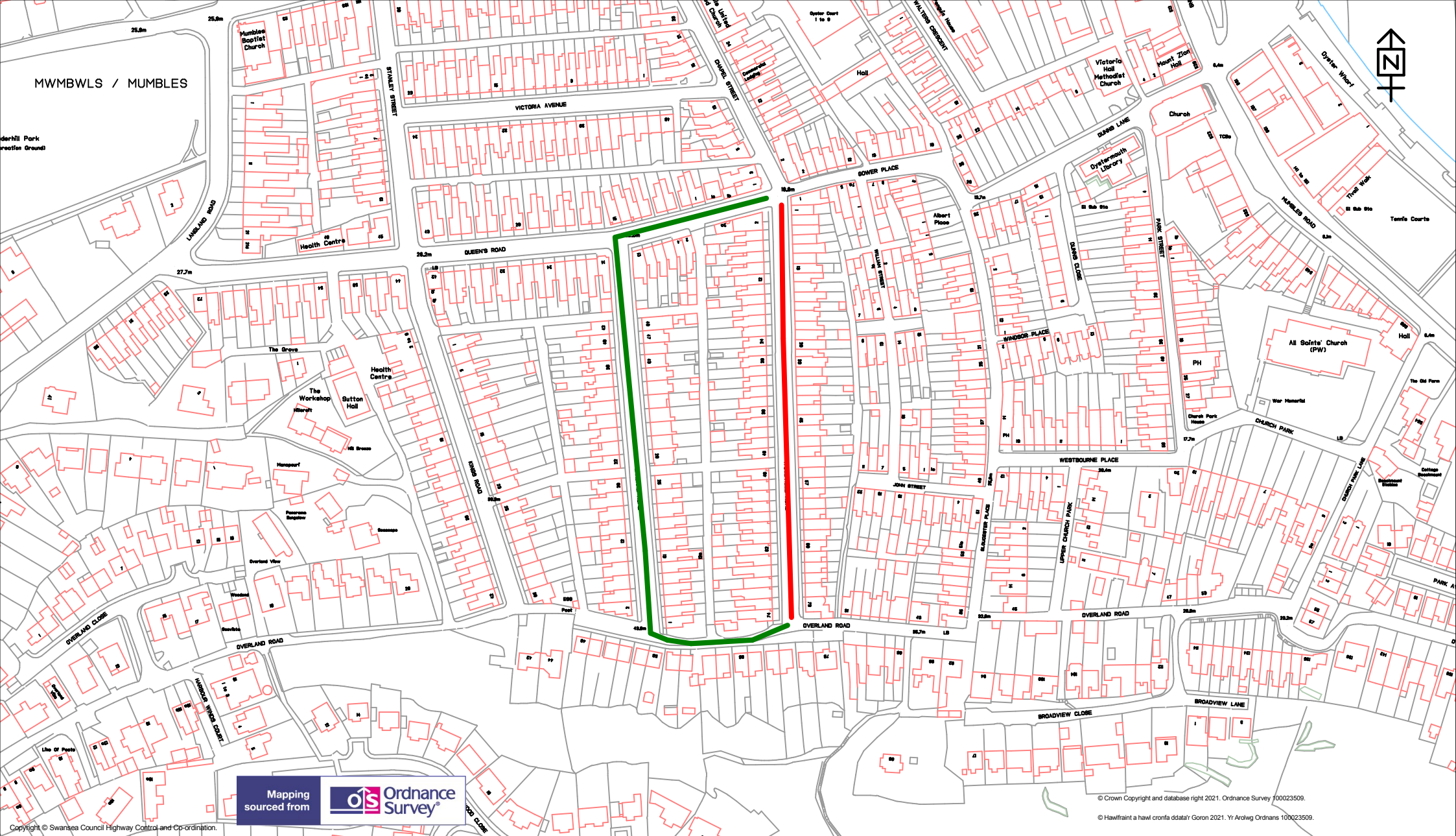
Access for emergency vehicles to be maintained at all times.

The applicant will be responsible for the erection and maintenance of all advanced warning, Road Closed, diversion and alternative route signs in accordance with Chapter 8 of the Traffic Signs Manual and the Traffic Signs and Regulations and General Directions 2016 for the duration of the works.
